

## GENERAL TERMS FOR THE CONDUCT OF PROMOTIONAL CAMPAIGN

### I. ORGANIZER

The campaign starts at 00:00AM on May 22, 2020 at all EKO petrol stations on the territory of the Republic of Bulgaria.

### IV. ADDITIONAL CONDITIONS

**A.** When visiting EKO petrol stations, all anti-epidemic measures indicated by the state authorities must be strictly observed. The territory of EKO petrol stations is entered only with a mask and a distance of 2 meters is observed.
